PROGRAMMATIC BRIEF

The MDG-F financed **54 joint programmes** across Latin American and Caribbean countries, for a global amount of **US\$ 301.2 million.**

Joint programmes were developed in **18 countries** of the region: Bolivia, Brazil, Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, El Salvador, Guatemala, Haiti, Honduras, Mexico, Nicaragua, Panama, Paraguay, Peru and Uruguay.

The **countries** receiving the **highest programmatic budget** from the total amount invested in the region were: Nicaragua (6 programmes and US\$ 39.2 million), Guatemala (5 programmes and US\$ 29.7 million), Bolivia (4 programmes and US\$ 28 million), Colombia (4 programmes and US\$ 25.7 million) and Honduras (3 programmes and US\$ 20.9 million). The **thematic windows** that canalized the highest share of resources for the region were Conflict

Prevention and Peace Building (10 programmes and US\$ 53.4 million) with emphasis in citizen security programmes, Children, Food Security and Nutrition (8 programmes and US\$ 52 million), Democratic Economic Governance, with emphasis on water and sanitation management (7 programmes and US\$ 40 million), Development and Private Sector (7 programmes and US\$ 38.7 million) and Gender Equality and Women's Empowerment (5 programmes and US\$ 35.4 million). JOINT PROGRAMMES COVERAGE IN THE REGION

Overall, it is estimated that more than **1,200,000 individuals** (1,247,559) were directly supported by MDG-F programmes developed in Latin American and Caribbean countries. Among these individuals, MDG-F programmes reached a total of **678,901 women, youth female and girls** (58% of the overall total of citizens).

Programmes involved and benefited **178,595** youth and more than **300,000** children, boys, girls and students (303,347). More than **24,000** civil servants were part of capacity building activities (24,573). In Latin American and Caribbean countries, programmes also engaged: **12,732** health workers, 4,165 teachers and trainers, **11,438** farmers and food producers and **29,980** entrepreneurs and culture professionals (artisans, artists, etc).

Of the above mentioned **1,200,000** right holders and agents, **453,000** were reached by actions promoted by **Children Food Security and Nutrition** programmes; **238,000 citizens** were reached by **Conflict Prevention and Peace Building initiatives** and **220,000** with initiative belonging to the **Gender Equality and Women Empowerment window**. Capacity building is a core characteristic of all joint programmes financed by the MDG-F. In the programmes financed across the 18 Latin American and Caribbean countries, participation in these included **504** activities Civil Society Organizations (CSOs), 8,928 local institution, 641

national public institutions, 744 schools, 331 communities, 83 indigenous organizations, and **1,035 Country Based Organizations** (CBOs). The programmes also strengthened the capacities of **437 private sector institutions**, mainly small and middle enterprises, cooperatives and business units.

Joint programmes Latin in American and Caribbean countries provided services that spam from capacity building to, nutrition, from food production to access to justice. By clustering the provision of services into different families, we estimate that: 278,523 children and mothers were reached by programmes aiming to improve their nutrition and health. 125,891 citizens were involved food production agriculture initiatives. 89,967

citizens were provided with services related to the creation/expansion of economic opportunities, including training, access to credit, employment opportunities and orientation via one-stop shops and others. 24,383 citizens participated in activities of capacity building on climate change and mitigation, 129,241 men and women benefitted by new infrastructures (including water and sanitation supply). Mainly programmes of citizen security, increased the access of 208,580 citizens to justice, conflict prevention and protection of right services. Figure 4 provides more details.

In addition, the programme in Honduras for the Culture & Development thematic window reports 1.4 million citizens reached by promotion of national culture and national products for local, national, and international markets.

POLICY INFLUENCE IN THE REGION

Across the 54 programmes developed in the region, the MDG-F has supported or promoted the approval or implementation of **125 national and 152 local policies**, **104 national laws and 52 national plans**, plus 372 local plans.

Millions of citizens have been affected by policies, laws and plans promoted via MDG-F joint programmes.
