Joint Programme Outcomes:


- (1) Increased exclusive breastfeeding (EBF) rate, by at least 20% annually;
- (2) Reduced prevalence of undernutrition in six JP areas, by at least 3%, in children 6-24 months old, by 2011; and
- (3) Improved capacities of national and local government and stakeholders to formulate, promote and implement policies and programs on Infant and Young Child Feeding (IYCF).




